Followed a training period for 9 months as a planter trainee (creeper) in a Regional Plantation Company, SLSPC or JEDB
  3. Having an experience not less than 3 years as an Assistant Superintendent in Organizations of Government/Semi Government or a recognized Regional Plantation Company.
- Extra Benefits** - Facilities under Indoor and Outdoor Medical Insurance Scheme.
