#### **Qualifications**

**External** : a. A four (04) year special degree with a First Class or Second Class Upper in Science or Agriculture from a recognized University with appropriate subject combination

**OR**

b. A four (04) year special degree with a Second Class (Lower) in Science or Agriculture from a recognized University with appropriate subject combination and a minimum of one (01) year postgraduate degree in the relevant field

**OR**

c. A degree in Science or Agriculture with appropriate subject combination and a two (02) year postgraduate research degree in the relevant field

**AND**

A PhD degree in the relevant field and a minimum of eight (08) years research experience after obtaining 1<sup>st</sup> degree.

**Note** : Publications relevant to the respective discipline will be an added qualification.

**Age, Salary code, Salary scale**

Should be not less than 30 years and not more than 45 years. The upper age limit will not apply to internal candidates.

**Job Description** : Responsible for implementing research projects, analyzing results & presenting data in specialized disciplines under minimum guidance from the Head of Department, Principal Research Officer and guiding Experimental and Technical Officers for collecting & recording data. Senior Research Officer will be responsible for implementing technology transfer programmes of the Department under the guidance of the Head of Department, Principal Research Officer.
